#### 6. Grant Award to First 5 Shasta 501(c)(3)

#### 7. Discussion of Goal Specific Grant Funds

Dickens updated the group that there was a review panel to select awarded Goal Specific Project Grants. Tim Garman was a part of the review panel and was enthusiastic about the applications. The review team decided to grant funding to Kids Turn who will provide a workshop around coparenting, Shasta College ECE for sand trays for play, and Shasta Family YMCA for new curriculum. There were two applications that were better suited as Sponsorships and will be funded through that grant type.

#### 8. Reports

A report on topics and important information related to the committee or position.

a. Admin Ad Hoc

There was not an admin ad hoc meeting to report on.

b. Evaluation & Advisory Committee

Barry noted that there was a good presentation on early intervention for the 0-5 population from the Community Health Alliance for Children and Youth. During the evaluation and advisory committee meeting, Jennifer Snider from Shasta County Office of Education reviewed a community survey.

c. Executive Director

Dickens reported the Champions for Children event that highlights the partnerships in the community and is a resource event for families at Turtle Bay on September 7<sup>th</sup>. The Car Seat Safety event in partnership with First 5 Shasta (F5S) and California Highway Patrol (CHP) will be happening on September 21st. There is a Burney Car Seat Safety event on September 19th. F5S will be promoting Reptile Safety event on September 28/29. Dickens mentioned that First 5 Association did a presentation to First 5 California around sustainability with declining funding. The individual county First 5's reminded the State commission through presentation that the funding is tied to the county commissions and not the State commission. Ayer asked if the message was received at the legislative level. Dickens highlighted that Dahle has always been a supporter of children and families but things at the state level take time. Mu asked for

clarification on how the funding is disseminated. Dickens replied that F5CA gets 20% of the tobacco tax, the remaining 80% get disseminated to the rest of the counties. Brainerd reminded the group that F5S is in audit season. F5S will have to go out for RFA for an auditor soon.

d. Commission

Cole noted that there will be a State of the City event at the convention center coming up.
