2. Public Comment Period

Grant Coordinator, Jackie Scott provided an update on the CDFA grant, reporting that six interns applied, with two fully committed to the program. These interns conduct a story, tasting, and planting activity at family childcare homes, engaging directly with the children. The first round of participation runs for six weeks.

Program Coordinator Megan Johnson updated the Commission on upcoming events. First 5 Shasta (F5S) and Help Me Grow (HMG) will host the annual Champions for Children event at Turtle Bay to connect families to resources and spend the day at the park. Admission is free for children ages 0–12 and \$2 per person age 13 and up. Additionally, F5S will be hosting a screening event for the movie "Sentenced" on September 4th Cascade Theatre 6pm. The movie is about how literacy can break the cycles of generational hardship. This "Sentenced" screening event will kick off the Dolly Parton Imagination Library in Shasta County.

The parent partners connect with the new families with partner support, nutrition and other resources. Additionally, Raising Shasta hosts parent cafes to help build community within these families. Plummer asked Berry how people hear about their services. Berry noted that they receive a lot of walk-ins to the resource center, referrals from the county, Shasta County Office of Education, Help Me Grow and other community partners.
