4. CYBHI Infant and Early Childhood Mental Health Grant Subcontract

Action Item

Poole updated the group that First 5 Shasta (F5S) was awarded a \$499,882 grant to provide Infant and Early Childhood Mental Health Consultation Services. Part of the subcontract is with Shasta County Office of Education (SCOE) to provide the clinical services. The contract award to SCOE is \$381,281. There is a possibility of no cost extension for the entirety of the grant through June 30, 2026. There is an approved budget and scope of work through 2026, but this specific contract will be to June 30, 2025, with the possibility of extending through 2026. Ayer asked if F5S would be receiving any funds, Poole described that it covers staff and administrative costs. Mu asked what age range SCOE will be able to provide service. Poole described that the clinical consultation will be for ages 0–5. Mu also asked how SCOE will reach those who need services. Poole replied that SCOE will serve 0–5 through their preschools and will outreach to Quality Counts North State to get

connected with children through early learning and care providers. There will also be outreach through Help Me Grow and the Resource and Referral office. Mu asked how many kids would be serviced, Poole replied 150 children and families.
