# 6. Funding Plan Revision

Dickens talked about adding funding to Week of the Young Child (WOYC) and Help Me Grow (HMG) budgets due to the cost increases. HMG was not able to receive funds in 21-22 through Dignity Health due to a technical application error. The award amounts need an increase for WOYC grant as they haven't been increased in years. Help Me Grow needs a \$20,000 budget increase to \$170,000 per year. Week of the Young Child needs a \$5,000 budget increase to \$20,000 per year.

### 7. Retirement Plan Vendor Selection

Dickens felt staff needed to have additional retirement plan options in addition to a 457(b). For the best interest of the agency, there is an additional 401(a) account available to staff. Currently, employees cap out at \$20,000 per year within the 457(b). By switching the 457(b) from Equitable to Principal, F5S will save about \$2,800 a year. Staff will also have access to financial advisement and trainings.

The grants for the new fiscal year will be opening July 1, 2022. Champions for Children event was very successful and according to counts there was about 350 nonmembers of Turtle Bay Exploration Park children between the ages 0-8. The Help Me Grow website is now in the development stage and should be available soon. Currently obtaining bids for landscape maintenance and the alarm/fire system for the building. Lone Fir Creative (MC2Design) will be hosting a StoryBrand session for staff and Commissioners to help build a better website and brand. Dodds inquired who was granted Goal Specific Project (GSP) grants. Poole described that F5S awarded GSP grants to Columbia Elementary School to support equipment for DRDPs, ASQ's and other screenings. KIXE for a big community story time event and equipment for ongoing community activities. TCCN for a new outdoor shed. NVCSS for technology for their home visiting program. Ready for Life to enhance their playroom for visitations for parents and kids to interact with. YMCA to continue to provide enrichment classes for toddlers and preschoolers.
